A.2010 Obedience/Rally Trial, Mary Ash

- 1. Mary Ash gave everyone a hearty thank you for all the help.
- 2. There is not a financial report yet.
- 3. Ribbon order was short since they were ordered before entries closed and based on previous year's order plus qualifying rates were high. Joy has ordered the additional ribbons needed.
- 4. Lots of compliments were received on the building.
- 5. Workers were in short supply although our rings were better manned than Vallejo's.
- 6. Gerry holding off securing judges for 2011 show until financials are finalized.
- 7. There will be a meeting with Vallejo to go over the NVDTC and VDTC joint trial endeavor.
- 8. A generous \$365.00 was collected for trophies. Any extra will go to ribbons; rest will be rolled over into trial expenses.
- 9. Raffle: There were a total of 45 baskets and raffle items bringing in \$482.00.
- 10. With all the new people that volunteered, it would have been good to set up stewarding training sessions.

B. Elections

- 1. There is one at-large vacancy on the Board that could not be filled by the nominating committee.
 - a. Bylaws state, when a vacancy occurs on the Board, it is to be filled by a majority vote of all the then members of the Board at its first regular meeting following the creation of such vacancy.
 - b. If anyone is interested in serving on the Board let Mary Ash know before the next Board meeting.
 - c. A member will be selected to fill the vacancy among submitted names at the next Board meeting.
- 2. The 2011 Board nominees as presented by the nominating committee was uncontested and thus officially elected.  - Laura and Lynda are looking at a Friday or a Saturday in February and also whether or not to have a luncheon or a dinner.

D.Vouchers

- 1. Board made the decision that juniors under 12 or those over 12 who need supervision do not earn a voucher, however their supervising parent will be eligible for one voucher regardless of the number of supervised children working at events.
- 2. Board recommended dollar values be reduced on vouchers as follows: Attending General Meeting: \$10; Committee Chairperson \$40; Active Committee Member \$30; Office Assistant \$40; Class Assistant \$40; Event Volunteer \$20; Board Member \$120 for one year of service
- 3. M/S/C to change the rates of vouchers listed above as recommended by Board.
- 4. A certain number of hours to be worked at trials have never been set.
- 5. Board decided vouchers would have no expiration date and are transferable.
- 6. Old vouchers for a full class will be grandfathered in.
- 7. New values for vouchers affective as of January 1, 2011. Old vouchers can still be used at their same value.
- 8. Board recommended use of vouchers be limited to \$80 per dog per class. M/S/C (with one abstention) to start the year limiting use of vouchers to \$80 per dog per class with a revisit of policy in six months. This does not include vouchers that are good for a class.

Dee is very proud of her boy and when he comes home in 2012, he will retire from the show ring to do whatever he wants and to go herding with her!


