# Thank You Dr. Bleviss!

We were very honored to meet Dr. Mara Bleviss on May 10 as she shared her extensive knowledge on vaccination protocols. Her background speaks to this knowledge. Born and raised in Los Angeles, she attended UC Davis where she earned a Bachelor of Science in Zoology and her DVM four years later. She started her career at Silverado Veterinary Hospital in 1986.

Dr. Bleviss evokes a down-home, sincere, and congenial personality; someone who really knows her way around animals. She married her husband, Mike, in 1992 and has three children, Nathan (born 1994), and twins Hannah and Jacob (born 1998). She enjoys watching her children play sports and spends her leisure time with her husband, children, two golden retrievers, five cats, and cockatiel. Her professional interests include rabbit medicine and surgery, emergency and critical care and softtissue surgery.

Her presentation on canine vaccination protocols to our group included three different categories: 1) Canine Core Vaccines, 2) Canine Non-core Vaccines, and 3) Other Canine Vaccines.

Core vaccines are recommended for all puppies and dogs with an unknown vaccination history. The diseases involved have significant morbidity and mortality and are widely distributed, and in general, vaccination results in relatively good protection from disease. These include vaccines for canine parvovirus (CPV), canine distemper virus (CDV), canine adenovirus (CAV) and rabies.

Non-core vaccines are optional vaccines that should be considered in light of the exposure risk of the animal, i.e. based on geographic distribution and the lifestyle of the pet. Several of the diseases involved are often self-limiting or respond readily to treatment. Vaccines considered as non-core vaccines are canine parainfluenza virus (CPiV), canine influenza virus, distemper-measles combination vaccine, Bordetella bronchiseptica, Leptospira spp., and Borrelia burgdorferi. Vaccination with these vaccines is generally less effective in protecting against disease than vaccination with the core vaccines.

> Several other canine vaccines are currently available on the market. These are vaccines for canine adenovirus-1, coronavirus, and rattlesnake envenomation.

# How a Pet Grieves: Understanding Your Dog or Cat's Loss

When contemplating the responsibilities of being a pet owner, most people usually think about the routine, day-to-day activities, such as feeding, bathing, exercising, and loving your dog or cat. Though these things are important, there are times when pets have

When a family member or another pet dies or leaves the household, it is important for a pet guardian to understand how their other pet[s] may be grieving, what signs to look for, and how to best support their grieving pet emotionally. There are actions you can take to help your pet recover and move on.



household. If you are sad and anxious, your pet will pick this up and mirror your feelings.

Signs that your pet may be grieving include sudden destructive chewing or clawing, whimpering, lack of appetite, constant pacing as if he is searching for his lost companion or owner, and emotional outbursts, such as snapping or growling at people. Your pet may also have changes in sleep patterns. You may notice that your pet craves more attention and reassurance from you, or loses interest in what were pre-

viously favorite activities.

Some things you can do to help ease your pet's grief include spending extra time with your pet, frequently petting and talking to him reassuringly, providing him with comfort items, such as favorite toys and blankets. For pets that have lost their owner, consider providing items that carry the scent of their owner such as an item of clothing or a

pillowcase. It is important to try to keep your pet's routine as much the same as possible, as the disruption in his regular routine may cause more distress. If an "alpha" pet has left the household or died, allow your remaining pets to establish their new pecking order, but step in if fights escalate.

The sudden loss of another pet or person that was previously an important part of your dog or cat's life can be disorienting and upsetting to your pet. Once you realize that your pet is grieving, you will be able to help your dog or cat during its grieving process with some extra TLC. If you have lost a pet, allow your remaining pets to re-establish a normal routine before you adopt another pet.

# Some Famous Film Star Dogs

# LASSIE:

Lassie is almost certainly the biggest stage name for dogs in the history of film. She was originally a character in a short story turned novel written by Eric Knight. The novel then became a movie (Lassie Come Home, 1943) and a series followed after (Lassie, 1954).



# BUDDY FROM AIR BUD:

Air Bud was a film that hit the theaters in 1997. The dog was played by a golden retriever named Buddy who was originally a pet trick dog in the David Letterman Show. His role in the movie won him instant reputation and even got him an Oscar award for his performance.

# FANG FROM HARRY POTTER:

Fang is the big hound dog from the manuscript and movie series Harry Potter (since 2001). He is a Boarhound in the book but is played by a Neapolitan Mastiff in the movie. He is in possession of Hagrid, a half-human, half-giant who is a very good friend of the main characters. In spite of his size and visual rage he is in fact very shy and gutless, as Hagrid himself points out. He does have his special moments of bravery though and can be very protective of Hagrid and his pals. Throughout the movie series three dogs have played the role. The first was Hugo who starred in the first three movies, Monkey who did The Order of the Phoenix (2007) and Uno who played the part in The Half-Blood Prince (2009).
