

My Red Girl

I lost my precious red golden to cancer. It was shocking how fast and debilitating it was—she was my little love and I am still feeling her loss with a heavy heart. Thanks to Sandy saying. "Perhaps God wanted Maddie back sooner," or as I thought, maybe Darcy needed his sister. I have listed her titles, but right now the titles are meaningless to me. I would rather have Maddie playing freely with her Frisbee or walking with me at the marina or begging and barking for treats.

One time at Austin Park, Darcy forgot to protect Maddie from other dogs and lost sight of Maddie. Dow owners, Lori and I searched for an hour. It was getting dark. I feared I had lost her forever. I finally found her sleeping under a tree. I was crying and hugging Maddie; relieved I still had my little girl.

Maddie loved to run in parks (where it was allowed) and check for chipmunks. Many times I would have to get her because she was too busy to heed my calls. For agility classes, Maddie had an internal debate whether she would run up the Martinez Hills or visit with the agility handlers or lastly, actually follow me though a course. Her choice was not always me.

When our wrecking crew grew to seven months and the destruction grew proportionally, we took them to Sirius Puppy training. With time Maddie got over her shyness and became more confident. I loved training Maddie. She seemed to enjoy our times training or, it could be, Maddie was looking forward to my expensive dog treats. We larned so much doing clicker training, tricks, recalls, long distance commands and stays. Maddie loved learning new skills. Debi Best


told me that Maddie taught me so much. She did. Some people told me how lucky Maddie was to have me. That was not true; I was grateful and lucky to have my one in a million girl.

There are more endearing memories of Maddie for me. She had a successful CD run at San Lorenzo. her open Q at Del Valle, and her Grad Novice title at Deep Peninsula. For competitions, the titles were not as memorable as the failures. The dropped dumbbell in Grad Novice. The missed down signal for the drop on recall at the Redwood Empire. Lori was running Maddie in Open Standard (agility). Maddie got to #15 (teeter) and thought running back to our canopy and to me was more fun. I just laughed. Another time for Excellent Standard we had a clean run until we reached the table (about 3/4 through the course) and was done. Maddie would not do the required "down." She stared at me smiling as if saying to me, "Not today." Maddie finally went down but with too many time faults we NQ'd. The last fun Open Standard run we had Maddie in was so "on" and she connected with me totally. Even Cathy Dutra said what a good run Maddie had. That was one run I wish I had taped.

For rally there were times when Maddie ran we were so connected and in tune as a team. At Deep Peninsula (four days before Maddie first became sick) I was calm even after I was late for the walk through and then I tripped over a sprinkler head. I let go of my worries and Maddie felt relaxed. So we had fun. Maddie was wonderful. Even Bea Moore remarked what a happy dog Maddie was. It was one of Maddie's best runs. There were grand NQs where Maddie was so on and I would miss a sign.

At County Wide she was perfect but I forgot the normal heel after the fast sign as we NQ'd. At the Napa Fairgrounds I missed a 360 degree turn. I passed right by it. I would not trade those NQs at County Wide for a green ribbon because Maddie was so happy and willing. I

remember Maddie at the Napa college diving on the grass before we got to the second sign trying to cool down when the temperature was 99 degrees. Maddie and I competed not for the ribbons but to find the connection with joy and not for robot perfection.

As Radar barked in class, Vange remarked, "That's what we get when we have performance dogs." That was Maddie as well. She was a ham. She loved to do tricks in front of audiences as well as dog dancing. She became radiant as the Danville crowd clapped when she ended her routine. I so miss those days.

Many people who sent cards to me stated how sweet and good natured she was. She was. Maddie willingly accepted both Penny and Jack. No jealousy. She was always friendly and when needed, calm and stoic. Our cats ruled her. If they wanted her crate or dog bed they would stare at her. She would get up and move. She never growled at the cats.

People thought it strange that I mostly went to the various dog shows alone. I had my co-plot with me. I constantly would update Maddie with how many miles we had left before arriving at shows or at home. We saw many beautiful areas, especially at the outdoor events. Those I cherish. As Suzanne Clothier stated, "I apologize for the mistakes I made but I will try to do better with the new generation." (My Jack.)

One exhibitor at our agility trial on Sunday asked if I would be at Mensona. I explained I could not because I lost Maddie. She asked how old Maddie was. She was 14.9 years. She said that was a long life. Yes it was but not long enough for me if Maddie was still okay. At Carmel one handler remarked how spry Maddie was. Then two days later cancer began once again its horrible path.

Maddie, my stoic baby, was in pain on Friday morning. I felt somewhat helpless because we could not find any vet to come to the house. Our vet did not provide pain meds. Our dear savior Darcy, in a way, rescued his sister. I remembered that Darcy still had some Tramadol. We gave a pill to Maddie and luckily that helped relieve her pain quickly. So she died in peace.

Lastly, I want to thank the trainers who helped Maddie and I through the years.

Rachelle Carzino: Puppy, some obedience, tricks, clicker, agility and allowing Maddie in class, jumping 12 inches. Maddie loved it.

Kelly Randall: CGC, rally, open obedience and tricks.

Barbara Dwyer: Open obedience, some novice obedience and a little utility. She finally taught me to be quiet, to heel properly and to throw the dumbbell properly–it is an art. Maddie loved Barbara.

Teresa: Obedience—a little novice, mostly open, some utility. We both loved your fun classes.
