## NACSW Challenge 2 2022/2023

Sixteen dog and handler teams from Donna Golemon's nose work classes joined up to compete in the Skills Achievement Challenge for the National Association of Canine Scent Work (NACSW) this summer.

Among the competitors, 10 master titles - the highest title possible -were awarded by the NACSW. Two teams won their NSA 3 title. Four more teams competed but the NACSW unfortunately closed the competition before their entries were ready for submission.
"All of the dogs and handlers did a fantastic job," Donna Golemon said. The NACSW agreed, complimenting both dogs and handlers on great demonstrations of search skills.
This is the second NACSW Skills Challenge that NVDTC students have participated in the past year. The competition runs were held at Napa Valley College and at the NVDTC clubhouse. The purpose of the Skills Achievement Challenges is to evaluate the dog's ability to efficiently and methodically work a search.
Each Challenge consists of four skills. For this challenge, dog and handler teams had to, with 2- minute limits, complete a vehicle search; search a blank room with no hides; find high/low hides and find an inaccessible hide.

Every skill has three levels of difficulty. Points are awarded based on which levels handlers choose to compete at, and the points total determine the title earned.
A good example of one of the harder skills is high/low:

- For Level 1, the first hide was placed one foot off the ground, and the second was four feet off the ground, with the hides 10 feet apart.
- For Level 2, the first hide was placed two feet off the ground, and the second was six feet off the ground, with the hides seven feet apart.
- At Level 3, the first hide was two feet off the ground, the second hide was six feet off the ground, and the hides were only four feet apart.
The NACSW has already come out with their next challenge. Donna's students are already preparing for their next Skills Challenge, scheduled for Oct. 7 at Napa Valley College.

On August 15, Toby and I had the opportunity to do scent work on the historic USS Hornet aircraft carrier in Alameda at the annual Invitational Mock NACSW Elite Trial. This event was sponsored by Mountain Dogs LLC (in Colorado!). The USS Hornet is a sea, air, and space museum that was closed to the public that day so 31 dogs could trial both inside the ship and on the decks. The four trials were very challenging, each with an unknown numbers of hides from zero to infinity. Toby found hides around a helicopter, a plane, and even the splashdown capsule from the first Moon walk! This was a nonsanctioned mock elite trial, so no points were earned; but the experience was once in a lifetime!
